Bible Verse of the Month



4 So, my dear brothers and sisters, this is the point: You died to the power of the law when you died with Christ. And now you are united with the one who was raised from the dead. As a result, we can produce a harvest of good deeds for God. 5 When we were controlled by our old nature, sinful desires were at work within us, and the law aroused these evil desires that produced a harvest of sinful deeds, resulting in death. 6 But now we have been released from the law, for we died to it and are no longer captive to its power. Now we can serve

God, not in the old way of obeying the letter of the law, but in the new way of living in the Spirit. 7...it was the law that showed me my sin. I would never have known that coveting is wrong if the law had not said, "You must not covet." 8 But sin used this command to arouse all kinds of covetous desires within me! If there were no law, sin would not have that power.

14 So the trouble is not with the law, for it is spiritual and good. The trouble is with me, for I am all too human, a slave to sin. 15 I don't really understand myself, for I want to do what is right, but I don't do it. Instead, I do what I hate. 17 So I am not the one doing wrong; it is sin living in me that does it. 18 And I know that nothing good lives in me, that is, in my sinful nature. I want to do what is right, but I can't. 19 I want to do what is good, but I don't. I don't want to do what is wrong, but I do it anyway. 20 But if I do what I don't want to do, I am not really the one doing wrong; it is sin living in me that does it.

21 I have discovered this principle of life—that when I want to do what is right, I inevitably do what is wrong. 22 I love God's law with all my heart. 23 But there is another power within me that is at war with my mind. This power makes me a slave to the sin that is still within me. 24 Oh, what a miserable person I am! Who will free me from this life that is dominated by sin and death? 25 Thank God! The answer is in Jesus Christ our Lord. So you see how it is: In my mind I really want to obey God's law, but because of my sinful nature I am a slave to sin.

GODFREY CONGREGATIONAL CHURCH MINUTES OF COUNCIL MEETING Friday, December 15, 2023

Members in Attendance: Bob Ridenour, Ferne Ridenour, Rose Mary Oglesby, Susan Wright, Betty Norman, Sue Orban & Jamie Orban

The meeting was opened with a prayer by Susan Wright. Scripture was read by Bob Ridenour: Luke 2:14. The meeting was called to

order at 4:33 p.m. Minutes of November 17, 2023 were reviewed by the council. A motion to accept the minutes as written was made by Susan Wright, seconded by Rose Mary Oglesby. Motion carried.

COMMITTEES:

FINANCE: Chair Ferne Ridenour reported the following amounts as of November, 2023:

Reuter Trust: \$253,909.99 (up \$5,310.79) as of 11/30/23. There was no income received this month due to a \$231.97 handling fee. [The principal of the Reuter Trust Fund cannot be used until November 14, 2038.]

Line of Credit: \$4,700.00 (as of November, 2023)

Building Repair Fund: \$90.00 [This fund can only be spent on large building, grounds, and/or equipment repair or replacement costs, as approved by the Church Council.]

Total expenses for the month of November were \$3,463.52 and our total income was \$2,608.74. Expenses exceeded income by a total of \$854.78. Our higher insurance bills were one of the main causes. Our monthly payment has gone up from \$787.62 to \$931.56; that is an extra \$143.62 per month, or \$1,584.00 per year.

FACILITIES & SUPPLIES: Chair Rose Mary Oglesby reported that the Salvation Army came on December 6th and picked up everything left over from the rummage sale.

PERSONNEL & NOMINATING: No report at this time.

CHURCH GROWTH & NURTURE: Susan Wright reported the following: We mailed out eight cards to our church family and friends, two for anniversaries, three for birthdays, and three Christmas cards. Growth and Nurture would like to send a big thank you to everyone that helped with the Hanging of the Greens on November 18. Cookie and Fruit Sunday will take place December 17th. At the Growth and Nurture meeting on November 26th, we decided who was bringing fruit and cookies.

CHRISTIAN DEVELOPMENT: Susan Wright reported that the average adult Christian Education attendance was 0 and the average attendance for our children's classes was 1. Sunday School Bible Study was not held and will not be held unless someone shows an interest in attending. When Jolene is not dancing in and learning from Susan's Biblical plays, they are in Children's Church. They have been decorating the nursery and reading about the birth of Jesus. One Sunday Drew Rodewald attended Children's Church, too!

PASTOR'S REPORT: No report at this time.

DEACONESS: No report at this time.

ACA REPORT: Susan Wright reported that the American Christian Academy is doing well and getting ready for Christmas with many holiday decorations. Nathan did a great job decorating the

classroom, school door, and office for Christmas.

The ACA reported the following accomplishments: We had an enjoyable Thanksgiving Day party with a movie, many snacks, and baking more cookies. Plus, we made turkeys for Thanksgiving to put on our bulletin board; we are now planning our next holiday party for Christmas, but there will be no Christmas program; ACA has reached 186 people in the last month and engaged 73; ACA has renewed our nonprofit status with the state of Illinois and no changes to our school board; and we now have a large sign for advertising with permission form the Church Council to place the sign in the north side front yard.

The ACA reported the following goals: File for a 501(C)3 with the IRS; design the sign and purchase posts; and have more students.

UNFINISHED BUSINESS:

None at this time.

NEW BUSINESS:

Dates were set for the next year's (2024) council meetings.

The Annual Meeting date was set for February 4th, 2024 and will take place after worship service. We will have a snack and appetizer fellowship hour after the meeting–all are encouraged to bring a snack or refreshment to share.
